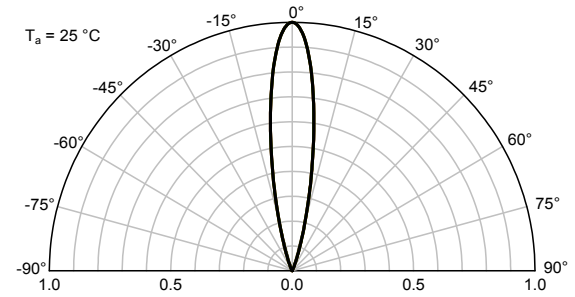

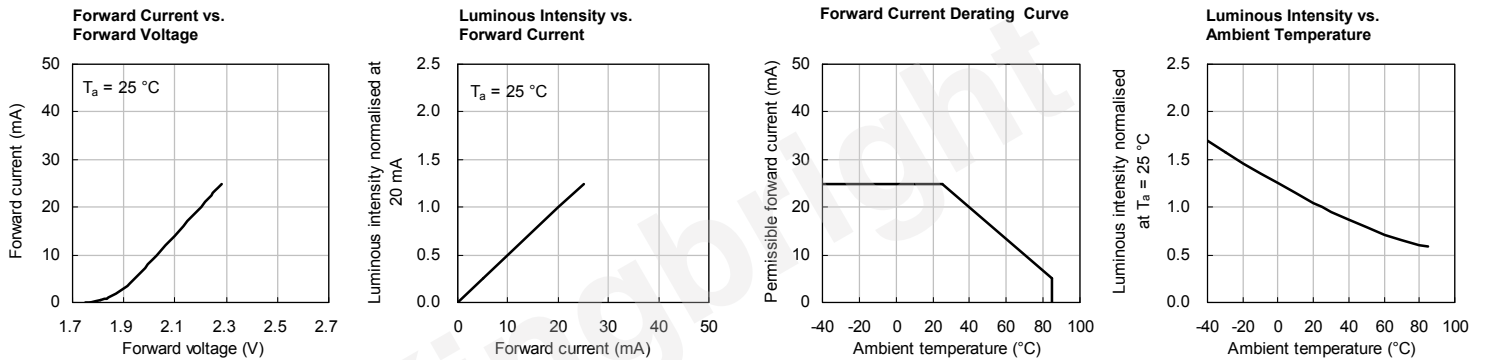
### RELATIVE INTENSITY vs. WAVELENGTH



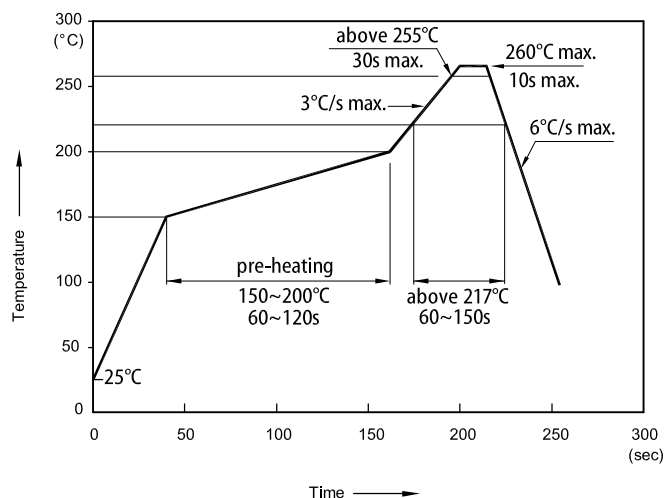
### SPATIAL DISTRIBUTION

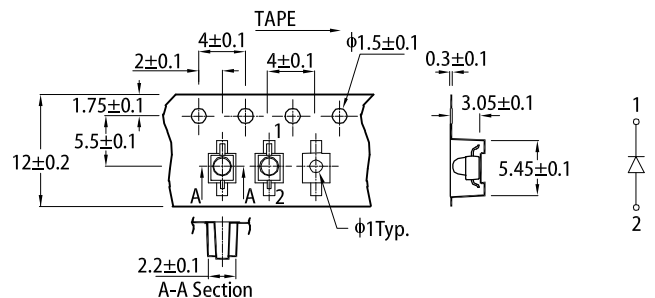


### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

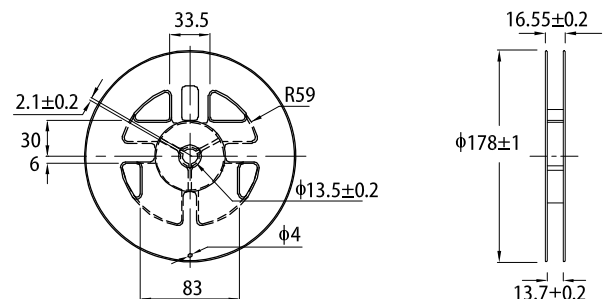


- Notes:

  - Reflow soldering is recommended. Other soldering methods are not recommended as they might cause damage to the product.

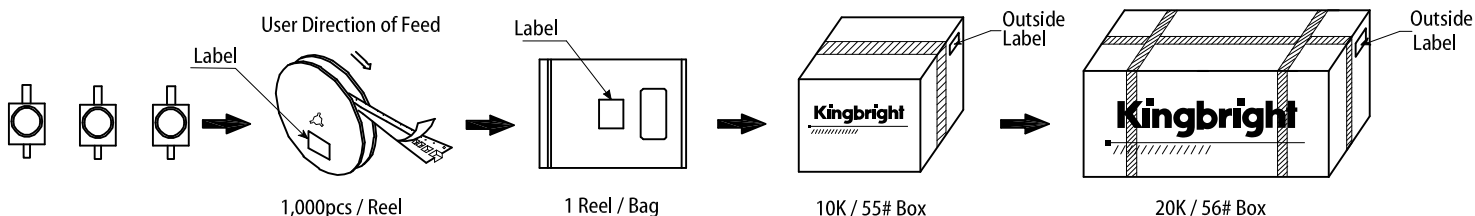
### TAPE SPECIFICATIONS (units : mm)
