


### **RELATIVE INTENSITY vs. WAVELENGTH**





# **SPATIAL DISTRIBUTION**













### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS




### Notes:




## **REEL DIMENSION** (units: mm)
