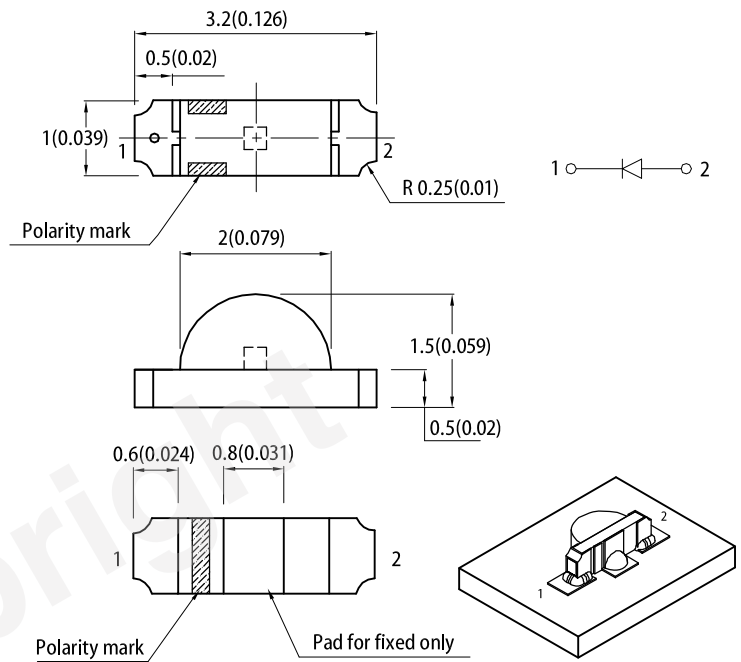

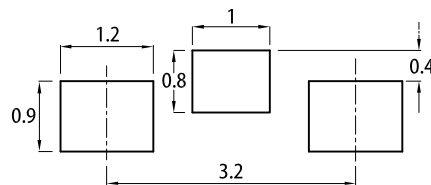

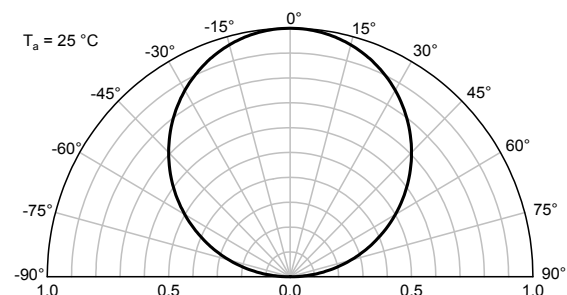

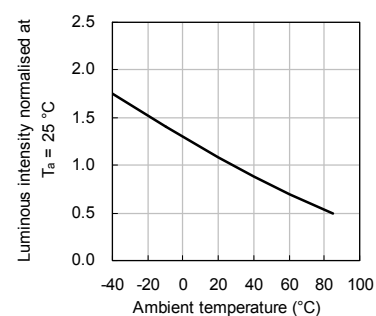

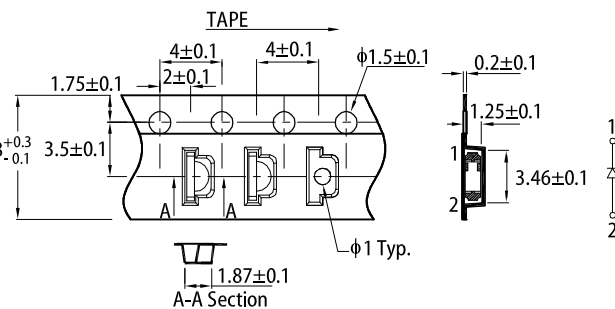
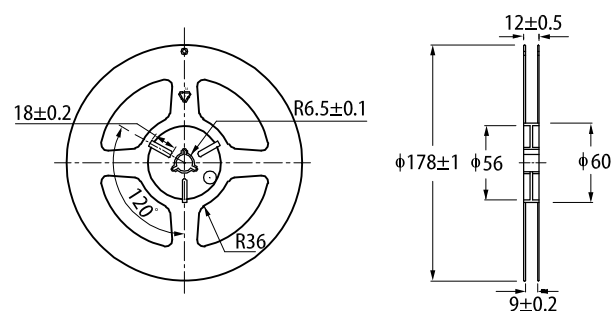
### RELATIVE INTENSITY vs. WAVELENGTH



### Luminous Intensity vs. Ambient Temperature

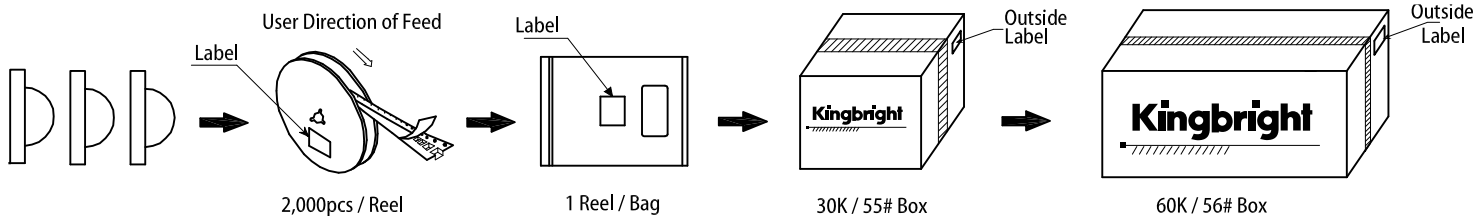
