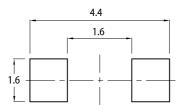

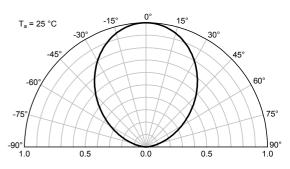

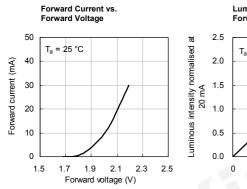
RELATIVE INTENSITY vs. WAVELENGTH Yellow 100%

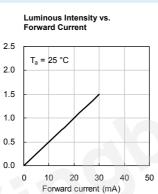


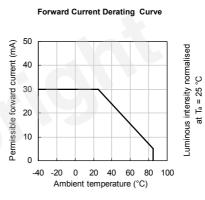
SPATIAL DISTRIBUTION



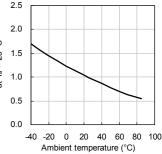

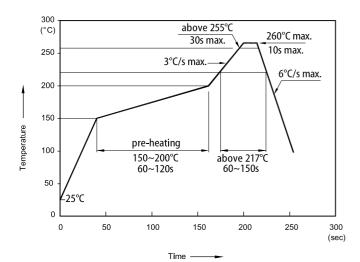




Luminous Intensity vs. Ambient Temperature

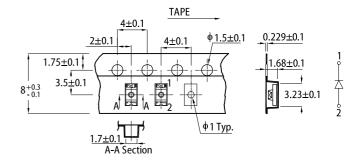


REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

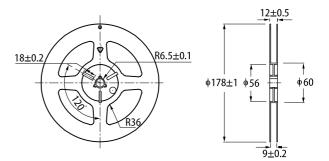


- Notes:

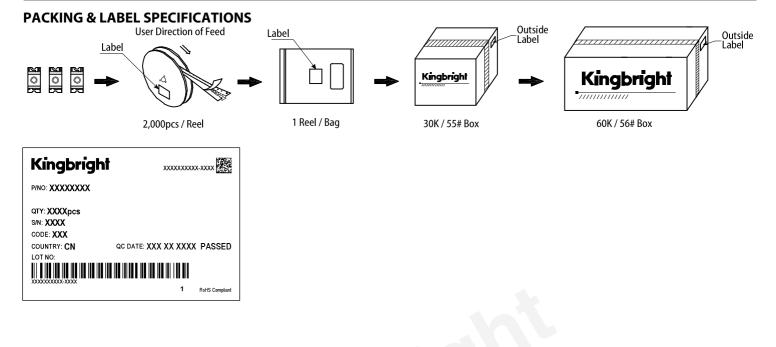
REEL DIMENSION (units : mm)
